Tracking Progress towards Non-Violent Childhoods

How do researchers track progress and change in attitudes and behaviours as a result of a legal ban on corporal punishment? What are the main considerations and lessons learned for planning and implementing studies and surveys? What are the main research questions and which methodologies are effective?

Prosecution or educational support?

Implementing the legal ban on prohibiting corporal punishment in all settings including in the home is challenging for all societies. How to ensure that social services work to their best in supporting the parents' capacity to change harmful behaviour? What methods work best to hear and interview children about their experiences and opinions?
